III. CURRICULUM/PROGRAM

BOARD ACTION

A. GOOD NEWS IN OUR SCHOOLS

- Transition from Everyday Math to Bits and Pieces is going very well. Students are doing a great job working together to discover concepts and strategies for solving problems, partitioning fraction strips, and are enjoying using them as manipulatives in class activities.
- Sixth graders completed creative projects on Ancient Egypt.
- The art department is working on interdisciplinary connections: Kindergarten is focusing on Celtic Art and Irish legends. Grade one is finishing a science-based lesson on polar bears. Grade 2 is studying African-American folk art through the creation of coil pottery. Grade 3 is learning about prehistoric humans and cave art. Grade 4 just finished a project whose background was composed of a "quick-write". Grades 5-6 are working on Chinese culture, Chinese Ink Painting and creating a miniature version of the Terracotta Army, while learning about Chinese origins.

- All students in grades 4-6 met with Mr. Smatla the week before Presidents Day, in the quarterly "Grade Level Meetings" to discuss goals for the 3rd marking period including: "Achieving One's Personal Best", "Creating Motivation for Success", and "Taking Our Work to a Higher Level".
- Mrs. Prall's fifth grade language arts students are working on individual writing pieces of personal importance. Students received instruction on various genres and writing for different audiences; students learned who to write for and how. Students will be guided through their piece with teacher and peer conferences, multiple revisions, and a final published version, which will be shared with the audience it was intended for.
- Mrs. Eisenberg and Mrs. Bargiel's math class has been working on fractions. Since there are many different fractional parts of a deck of cards, the students explored a deck by answering related questions.
- Stevenson School's Student Council organized a Math-A-Thon to raise money for St. Jude Children's Hospital. The students at Stevenson raised \$4,760.50 for children seeking medical attention at St. Jude's.
- Stevenson School students broke the one million minute reading mark as part of the Reading Challenge. The current total is 1,219,565 minutes. We have challenged students this year to read 2 million minutes.
- We celebrated Dr. Seuss's Birthday with an assembly visited by none other than the Cat in the Hat. An article is scheduled to appear in this week's edition of the Progress.
