#### V. PROGRAM/CURRICULUM

# A. GOOD NEWS IN OUR SCHOOLS District-Wide

Students district-wide participated in No-Name Calling Week with many activities, including lessons prepared by Ms Crescibene in health classes, and the creation of a large mixed-media art piece representing kindness and a positive school culture for all, coordinated by Ms. Cecere.

#### Stevenson School

- The kindergarten children are learning about winter birds. They have been listening to expository text to determine which birds stay in our cold temperatures for the long winter months. Students figured out that snow can cause problems for the birds, especially when they are trying to find food. The children enjoyed making birdfeeders to hang at home and are happy that they will be helping our fine feathered friends.
- The first grade students have been busy creating their own narrative stories using sequencing words, a narrative diamond, and adjectives. In social studies, the first graders learned about the various community helpers in Fairfield and Stevenson School.
- Second grade has been working on increasing lexile levels in Achieve 3000. They are also using a program, IXL, to help increase math skills. In reading, they have been comparing fiction and informational text using our new reading series Ready Gen. In math we have been exchanging money and counting coins. In Social Studies they have been studying the map of NJ, the continents and the world. They also have learned the importance of Martin Luther King Jr. and the changes he made for all people. Since February is Black History month, the second graders are individually working on a biography based on a famous black person. These biographies will be presented in class. Second grade teachers have recently begun to incorporate Google classroom into the curriculum.
- Third grade is learning language arts and social studies using the text, *If The World Were A Village*. Students are enjoying learning about the different nationalities, languages, religions, food, etc., that make up our world.
- Third grade teachers have incorporated Google classroom into the third grade curriculum. Teachers assign projects/homework using this new technology. Students are able to complete assignments, answer questions, and post comments either at home or at school. As they explore using this new technology they will be posting announcements, questions, and links to explore. Students will be asked to post replies and comments. The exciting part is that, at times, the students will be able to view each other's responses

#### Churchill School

- Students in grades 4-6 celebrated the conclusion of a month-long reading incentive program called "Reading Wonderland", receiving prizes for their work at home. 225 students in grades participated, reading at least 20 minutes a night and writing about what they had read. About 60 students who achieved at the highest level received about 45 minutes in a "game room" on Martin Luther King, Jr. Day, as the reward.
- The students in Chorus, Band, and Orchestra participated in Buddy Day at the WEHS along with fellow music students from the other sending districts on January 12. They spent the morning rehearsing music with the Middle School students and then performed for each other in an afternoon concert. In addition, the 6th Grade Special Chorus went caroling around the community near the Stevenson School on Monday evening, December 21. This is an annual event enjoyed by the students and the families visited by these enthusiastic singers!
- Fourth grade students are practicing targeted math skills using the new IXL program, which is a differentiated online skill building program to further their academic success.
- Fifth grade students participated in "book club" circles in which they read differentiated texts and produced creative projects, writing assignments and held discussions based on the unit topics.
- Our sixth grade students are advancing in the world of learning with technology. They are using Google Classroom for daily lessons and assessments, and have recently begun to use the IXL program.
- Sixth graders have completed their FREE VERSE poetry written in library class and based on Novels-in-Verse and they have been compiled by Ms. Goodman for presentation to the Board and administration.
