C. <u>Good News (October and November Events)</u>

Stevenson School: October

- In the month of October, Kindergarten students were busy learning about Fall. They read many different stories and made various fall projects. A highlight of this unit was learning about the life cycle of a pumpkin. Students even took a field trip to Fairfield Farms to go pumpkin picking. The culminating activity was carving a class pumpkin into a jack-o-lantern.
- Did you know that bats have fur? Well the first graders do! They read the classic story of <u>Stellaluna</u> by Janell Cannon. After hearing the story, the students

discussed the theme of friendship, compared bats and birds and then went on to learn more facts about bats. The students then took their knowledge of bats and created an expository writing piece all about bats.

- Second graders have been using elaborative detail in their writing! They learned to apply specific detail generating questions and a variety of sensory details to write an elaborative segment. They created and described their very own scarecrows and presented them to the class. Around Halloween, students enjoyed creating jack-o-lantern descriptions using elaborative detail and then they read them with a flashlight. Finally, second graders are currently working on a similar project using turkeys, but with a twist! This time they have challenged themselves to use word referents for their turkey! In math, they used a turkey friend to make equivalent names for numbers. The turkey feathers served as name collection boxes.
- Third grade students are just finishing up their second novel of the year, <u>Because of Winn Dixie</u>. To close out the author study of Kate DiCamillo, students are planning a potluck party and watching the film, "Because of Winn Dixie", as a grade level in the gym. Students are working very hard learning to type essays and using chromebooks in class. If you take a walk down the red hallway, you will see some beautifully printed work!
- Student Council collected about 700 items for the Blessing Bag Brigade. Common life necessities such as shampoo, toothpaste, deodorant, and socks were collected over the course of a week. Once collected, the organization brought the items to local special needs schools for the children to assemble the "blessing bags". Once bagged, the blessing bags were handed out at local soup kitchens, homeless shelters, or even the streets of NJ. The third graders had an opportunity to meet Kevin, the Blessing Bag Brigade founder. He spoke to the students about how and why he got started, and then took the students' questions.
- Third Grade HEP/S.T.E.A.M. students have reverse engineered car seats to understand how the product was designed and built. Sergeant Niemiec gave a presentation to students regarding the importance and safety of car seat installation.

Stevenson School: November

• Kindergarten was very busy in the month of November preparing for their annual Thanksgiving play and feast. They learned all about the Pilgrims, Native Americans and the first Thanksgiving. The students made various projects throughout the month which were used as decorations for the Thanksgiving play and their costumes. This year, the students even had several parents in the audience that had performed many years ago when they were in Kindergarten. This is a wonderful holiday tradition everyone looks forward to.

- First grade expressed what they are most thankful for in a writing piece. They are working on a surprise for the students' families as a holiday gift.
- Second graders are incorporating computers into the classroom. They share a computer cart which is rotated to each class. Students have been using RAZ Kids and IXL to practice reading and math skills. They have also been writing hooks and extended endings. They are currently working on a "Show, Don't Tell" project where students have to guess the emotion that they are feeling using body language and facial expressions in their descriptions. They are all excited to present them to the class and challenge their peers to guess! During Ready Gen, students are practicing "Response to Text" questions where they must restate, use evidence, and add a conclusion. They are excited to see what December will bring!
- Third grade students just finished reading the story, "Molly's Pilgrim." This kicks off the unit about traditions. Students are finishing their writing about their family traditions during the holiday season. This is an opening activity to learn and write informational text about different cultures around the world.
- Third grade students have also been working with Mrs. Farrell, Mrs. Valenti, and Ms. Fitzpatrick on a science project to end the unit on Weather and Climate Patterns.
- The HEP second and third graders have created their own dance party by developing programs that responded to timed events, user input, and created dance animation with code (block based lettering). Students learned how to combine coding and dance in a creative way using blocking based coding.
- Stevenson Student Council planned a team building event. Each "birdhouse" will create a Winter Bulletin Board display. Be sure to check the halls for their amazing displays at the end of the month.

Churchill School: October

• The fourth grade has enjoyed reading their first novel. They learned a lot about the adventures that occurred with the characters in the text, "The Cricket in Times Square." Students look forward to their next reading unit. In math, they have been working with factors and multiples and are also excited to identify square numbers using arrays. Finally, students are continuing to investigate energy in science. They built a circuit that was able to successfully deliver electricity to a light bulb. They can't wait for what will come next!

- After reading and annotating mentor texts such as, "Eleven" by Sandra Cisneros, and "The Blue Spruce" by Mario Cuomo, sixth grade students spent weeks crafting their first major writing piece. This piece focused on a significant moment and how it changed the author, which is called a memoir. Students were required to "dig deep" to find that one special moment and the end result was a collection of moving pieces that reveal the innermost thoughts and feelings of our budding writers.
- Churchill School's Student Council has been working closely with the Fairfield Police Department's Community Policing Unit this year. The Student Council sponsored an anti-bullying assembly in October and invited Officer Frank Tracey to make a presentation. They also just successfully completed "OPERATION SHOEBOX," a holiday collection for less fortunate children.

Churchill School: November

- The fourth grade wrapped up their science unit on energy. Students enjoyed comparing series and parallel circuits. Did you know that the energy source for a circuit is a battery? In math, they investigated the difference between triangles by analyzing their angles and sides. Students can classify both triangles and quadrilaterals by their properties. Next, students learned about prime and composite numbers.
- The fifth grade has been working diligently on the "Escape Room-Carnival" which will take place on February 15, 2019. They have been creating riddles and problems to solve and have begun constructing the actual walls in which their escape rooms will be contained. These tasks will be completed by the entire Churchill student body. In ELA, the fifth graders recently began studying the new unit which focuses on the challenges they face growing up. Students will analyze the characters in their novels and discuss the common themes of challenges they face throughout the marking period.
- On Thursday, December 13, the sixth graders will be venturing to West Essex to watch their winter concert performance. It will be a great opportunity for many of the sixth-grade students to not only walk the halls and familiarize themselves with their "soon-to-be school," but it will also give all students a chance to interact with band/chorus members and teachers/instructors. The sixth-grade teachers anticipate that all students will represent themselves and the Winston Churchill School community appropriately.

District

- Both schools' Art Clubs have been working on beautifying the schools' hallways by hand-painting murals on the walls. All images are based on themes that promote a positive learning environment. The students have been working cooperatively to draw, outline, and paint these images. They look forward to revealing the newest murals in the near future!
- Student council students participated in the National Jeans for Troops Day on Wednesday, November 7. Both staff and students donated \$1.00 each to wear jeans. The district collected \$1,056, which was donated to the GI Go Fund. The students met at the end of the month to plan for December. They have asked to make a monetary donation to the Wounded Warriors fund. This will be in the form of a "guess how many jar."

WHEREAS, the governing body of the Fairfield Board of Education, hereinafter referred to as "LOCAL UNIT" has determined that membership in the FUND is in the best interest of the LOCAL UNIT.

NOW, THEREFORE, BE IT RESOLVED that the governing body of the LOCAL UNIT hereby agrees as follows:

- i. Become a member of the FUND for the period outlined in the LOCAL UNIT's Indemnity and Trust Agreements.
- ii. Will participate in the following type (s) of coverage (s):
 - a.) Health Insurance and/or Dental and/or Prescription as defined pursuant to N.J.S.A. 17B:17-4, the FUND's Bylaws, and Plan of Risk Management.
- iii. Adopts and approves the FUND's Bylaws.
- iv. Execute an application for membership and any accompanying certifications.

BE IT FURTHER RESOLVED that the governing body of the LOCAL UNIT is authorized and directed to execute the Indemnity and Trust Agreement and such other documents signifying membership in the FUND as required by the FUND's Bylaws, and to deliver these documents to the FUND's Executive Director with the express reservation that these documents shall become effective only upon:

i. Approval of the LOCAL UNIT by the FUND.

- ii. Receipt from the LOCAL UNIT of a Resolution accepting assessment.
- iii. Approval by the New Jersey Department of Insurance and Department of Community Affairs.
