C. Good News

- The kindergarten students have been busy learning all about the life cycle of a pumpkin. Students read many pumpkin stories and illustrated their favorite parts in their journals. They made various pumpkin projects to go along with the pumpkin theme. Students carved a class pumpkin and counted how many seeds were inside, to practice their counting skills. A highlight was when Fairfield Farms delivered pumpkins to school for the students' very own kindergarten pumpkin patch. Each kindergartener got to pick a pumpkin and take it home. We were so happy to be able to welcome back our class moms to participate in our annual Halloween parade and class parties.
- The first graders went on a walking field trip to the Fairfield Public Library. On the way, they were able to see the newly erected Christopher Columbus statue, which was perfect timing for their social studies lesson! In science, first graders are learning about the day and night sky. The class was lucky enough to catch a glimpse of the moon during the day! Students carved a pumpkin during math class. This lesson was cross curricular with science, incorporating being a scientist. The children made predictions about weight, measurement and number of seeds. They also guessed if the pumpkin would sink or float! The largest amount of seeds out of all 5 classes was 593. The children had so much fun investigating together!
- For Halloween, second grade students completed lots of fun activities including Candy Corn Math, Roll-a-Witch, and writing spooky stories. In science, students began a unit on matter, and students were able to sort matter into categories as well as identify properties of matter in a scavenger hunt around the classroom. Additionally, students have joined their teacher's Google Classrooms, and are practicing computer skills such as dragging and dropping information into its proper place. For Columbus Day, students read and answered questions about Christopher Columbus and watched some informative videos about his journey.
- Third grade students are writing nonfiction books. They are researching animals, football teams, cars, and more. Their work is proudly displayed in the red hallway for staff and students to see. This month, the third grade will have a Thanksgiving feast. Thank you to the HSA for sponsoring the event. Third grade is really looking forward to this!
- Student Council students have been collecting nonperishable food items for the St. Thomas More food pantry. The collection is off to a great start! Coming up, students will be doing a thankfulness tree and display all of the things they are thankful for.
- Our fourth graders have had a seemless transition to Churchill School. They are excited to be back in school with their classmates and teachers. In reading, they have just completed their first novel, "The Cricket in Times Square". Students read about a country cricket who had to adjust to living in New York City. Throughout the story, students learned about character traits and types of conflict, as well as themes. In writing, students are practicing how to restate and write in complete sentences. Additionally, they are finding and citing text evidence to support their answers. Grade four started their second math unit which is multiplication. Students are working on their fact fluency and how to use an area model to solve multi-digit multiplication problems. Geography was their

focus in social studies during this marking period. Students learned about directions, parts of a globe, latitude and longitude and the five regions of the United States. The students are looking forward to the second marking period where they will begin a study of Earth through experiments and activities in science.

- Fifth graders are ending the first marking period strong. In reading, students are enjoying the novel "Wonder," by R.J. Palacio. They have been focusing on many foundational reading skills such as character traits, theme, and conflict. Students created a diary entry for one of the main characters in the novel using their newly acquired vocabulary words. In writing, students explored figurative language while creating a "Best Part of Me" poster and essay. They have also been utilizing their decorated writing journals to generate ideas for their personal narratives. In our second math unit, students will build on their understanding of the structure of the place value system by extending that understanding to decimals. Through our study of decimals and the base ten structure of our number system, students will understand how to read, write, compare, round, add, and subtract those numbers. In addition, students will learn how the base-ten system relates to the Metric System for length. In science the fifth graders are learning that Matter matters! The students have been focused on their familiar environment. They have examined types of matter and differentiated among solids, liquids and gases. They have performed activities to observe and measure mass and volume in samples of these three states. Through teacher demonstrations and hands-on interactivities, students have explored buoyancy, hardness, magnetism and viscosity as well as several other observable properties of matter. We will continue to explore and conduct a variety of concrete experiences that will allow the students to discover both physical and chemical properties of matter. In social studies, the students began the study of geography. During this topic of study, students were able to identify locations using a compass rose, identify information using the regions of the United States, explain the purpose of using latitude and longitude. They had a culminating activity/project related to the U.S. regions. During this project, students worked collaboratively to research a specific region of the United States. Research included states and their capitals, climate, natural resources, landforms, industries, and places of interest. Then they created an informative, attractive slideshow using all of the research to share with their classmates. The student's will use this knowledge as they explore our net unit, The First Americans.
- The sixth graders have adjusted well to all the new changes in grade six. Of course, the lockers were the biggest and most exciting challenge. It took awhile, but the students are now proficient in spinning those numbers around. In science, the students have been to the moon and back. Social Studies has them traveling down the Tigris and Euphrates Rivers, searching for artifacts. Novels, novels and more novels, it's all about reading and writing. The students are enjoying many different authors including, Lynda Mullaly Hunt, Roald Dahl, and Suzanne Collins to name a few. Their personal narratives in writing class have revealed many interesting facts.
